# Think Gerontology, It's Rewarding!

International Perspectives on Ageing

Mark Twain, the author of American classics like Tom Sawyer and Huckleberry Finn had once said that "Age is an issue of mind over matter. If you don't mind, it doesn't matter."



My own life resonates wholly with this powerful quotation. I was 50 years of age when India's first corporate hospital – Apollo Hospitals in Chennai opened its doors offering tertiary care of an international standard. Typically back then, most people contemplated retirement the moment they turned fifty!

The situation though has changed a lot since the seventies. Modern medicine is greatly assisting in the early detection of diseases; accessibility of advanced treatment modalities, awareness of wellness and many such factors have led to overall longevity and improvement in life expectancy. One can say that they have added about 30 years to the average life span.

As a nation though, we have a long way to go in giving Geriatric Medicine as much attention as is given to other medical disciplines. A pivotal reason for this apathy is the negativity continuously reinforced by the media and innumerable marketers who sell anti-aging products and services suggesting that aging is not acceptable. Growing older is a natural course of life and its needs should be accepted and acknowledged by individuals and society at large.

A recent study conducted by the Indian Ministry of Health showed that one in every four among India's elderly population is depressed, and one in three suffers from arthritis, while one in five cannot hear. While one in three suffers from hypertension in rural India and one in two in urban areas, almost half have poor vision. Around one in 10 experiences a fall that results in fracture, while two in five are anemic. One in 10 in rural India and two in five in urban areas suffer from diabetes, with nearly 31% suffering from bowel disorders. This situation needs to change.

As responsible members of the healthcare fraternity, the two key questions that we should all ask ourselves are whether our people are living longer and if they are living healthier.

The western world is witnessing a growth of the aging populations and India too is not far behind. The 60-plus age group in India is about 100 million and the elderly population will increase to 12% of the total population by 2025. India needs to be conscious of its demographic transition and promote healthy aging of its population to improve societal productivity and prevent avoidable economic loss.

I am heartened that Apollo College of Nursing in partnership with the advantAGE Seniors, Bangalore has organized a very pertinent seminar on 'International Perspectives on Ageing' providing a platform for discussion on the issues and actions needed to enhance nurses' contribution in promoting quality of life for the ageing population.

A nation is defined by its people and we should be relentless in our focus to improve the health of older adults through continuous training for our caregivers and encourage more clinical research in the subject.
